Segregation of Duties (SoD)

Segregation of Duties (SoD) in IGA prevents fraud and error by ensuring no single user has overlapping permissions to initiate and approve the same critical business process or sensitive transaction.

Access Certification

Access Certification is a periodic IGA process where managers or owners evaluate and verify user permissions. It ensures employees hold only necessary access, preventing "privilege creep" while maintaining security standards and achieving regulatory compliance through automated remediation, detailed audit logs, and continuous enforcement of the Principle of Least Privilege.

Compliance Reporting

Deliver audit-ready reports to meet ongoing compliance requirements. Provide auditors with detailed, real-time reports that includes identity governance and administration data about what resources are in your environment, who has access to them, when, and why that access was granted and terminated.
